WAIVER AND RELEASE OF LIABILITY

NOTE: This document must be read in its entirety, signed and returned to the Punt Race Steering Committee before participating in any Race activity. In consideration of being allowed to participate in any activity organized and/or supervised by the Punt Race Steering Committee (the "Committee"), the undersigned acknowledges, understands, and agrees that:

- The risk of injury and/or death from participation in any activity on the run exists, and no preplanning, rules, or equipment can remove all such risk, AND THEREFORE BY PARTICIPATING IN SUCH ACTIVITIES, I UNDERSTAND THAT I MAY BE SUBJECT TO SUCH RISK OR PERSONAL INJURY; AND
- I KNOWINGLY, WILLINGLY AND VOLUNTARILY ASSUME ALL SUCH RISKS OF INJURY, both known and unknown, regardless of severity of risk and/or injury, EVEN IF ARISING FROM THE NEGLIGENCE OF THE PUNT RACE STEERING COMMITTEE, ITS EMPLOYEES, OR AGENTS, and
- I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin (hereinafter collectively referred to as "I"), hereby release the Punt Race Steering Committee, its employers, directors, members, officers, or any other agents, FROM ANY LIABILITY WHATSOEVER WITH RESPECT TO DISABILITY, DEATH, OR ANY AND ALL INJURY, LOSS OR DAMAGE TO PERSON OR PROPERTY, WHETHER CAUSED BY THE NEGLIGENCE OF THE PUNT RACE STEERING COMMITTEE, ITS EMPLOYEES OR AGENTS, OR OTHERWISE; and
- I HEREBY INDEMNIFY AND HOLD HARMLESS THE PUNT RACE STEERING COMMITTEE, its employees, directors, members, officers, or any other agents, OF ANY AND ALL CAUSES OF ACTION, CLAIMS, DEMANDS, LOSSES, OR COSTS OF ANY NATURE WHATSOEVER, arising out of or in any way related to my participation in the Race;
- I HEREBY WAIVE ALL RIGHTS TO FILE OR PROSECUTE ANY CIVIL ACTION AGAINST THE PUNT RACE STEERING COMMITTEE, its employees, directors, members, officers or any other agents, FOR DISABILITY, DEATH, OR FOR ANY INJURY, LOSS OR DAMAGE TO PERSON OR PROPERTY IN ANY WAY RELATED TO OR RESULTING FROM MY PARTICIPATION IN ANY ACTIVITY ORGANIZED and/or SUPERVISED by the Committee.

RESTRICTIONS

- Punts MUST NOT be modified in any way, shape or form (flags, marks, logo's, drawings, etc...) and must adhere to punt specifications as outlined on the Great Fogo Island Punt Race web site
- All punts MUST be returned to Shorefast Foundation 48 hours prior to race.
- Any medical condition(s) of rowers MUST be listed above.
- VHF radios are mandatory and rowers are responsible to supply them.

REQUIREMENTS

- Applicants must be of adult age (18 years or older). Applicants may be of 17 years of age, however they must be accompanied by an adult rowing partner.
- A team consists of exactly two rowers per punt. Mixed teams only (consisting of one male and one female).
- *Deadline for Registration for Grandfathered Teams is Tuesday February 28th, 2017.
- All registration forms and fees must be received by registration deadline in order to be eligible. Fees are non-refundable.
- One registration form is required for each individual rower (2 forms per team).

I have read this agreement and fully understand the terms specified above under waiver and release of liability, agree to items specified above under rules and restrictions and I am freely and voluntarily agreeing to such terms by signing below, thereby executing this agreement at Fogo Island, on the 15th day of July, 2017 or any day thereafter pending weather delays.
